In March 2009, Arch Insurance Europe received approval from the Lloyd's Franchise Board to establish Syndicate 2012, a new Syndicate at Lloyd's. Syndicate 2012 is managed by Arch Underwriting at Lloyd's Ltd, Arch's managing agent authorised by the FSA. Syndicate 2012 commenced underwriting risks from April 1, 2009. For the 2011 year of account, Syndicate 2012 has a stamp capacity of £250,000,000.
